




OPTION 3 (SR) TO-247AD






Fig.1-Typical Junction Capacitance Vs.Reverse Voltage

Fig.2-Typical Values Of Reverse Current VS.Reverse Voltage




Fig.3-Typical Forward Voltage Drop Characteristics
